NACO Executive Members are very excited to be able to host their first face to face Training Event since the special one-day event in November 2019 which coincidentally also took place in Birmingham. We were well supported by the City Council on that occasion and had no hesitation in accepting an invitation to return. The 2023 in AGM will be the first one in person since the spring of 2019.

We were very pleased with the success of our on-line Training Events which we held in 2021 and 2022 but we are only too aware, having been told by delegates that nothing can replace the value of networking. To this end we have ensured that the programme offers plenty of opportunities for this.

## **Keynote Speakers**

Andrew Dent is a senior civil servant with wide experience across government. In 2022, he has been Head of The Queen's Platinum Jubilee Team, a Director of the Birmingham 2022 Commonwealth Games Government Coordination Centre, and a Silver Command for Operation London Bridge (The Queen's Funeral).



Before this, he was Deputy Registrar General for England and Wales and has worked in policy and

operational roles across the immigration and criminal justice systems, and as Director of the Identity Cards Programme. He has also worked as a Private Secretary to the Home Secretary and The Queen, as Secretary to independent Inquiries into policing and the murder of Daniel Morgan, and on major events including Millennium Eve, the Golden Jubilee, Manchester 2002 Commonwealth Games and London 2012 Olympics.

Andrew was made a Member of the Royal Victorian Order (MVO) in 2000 and is a trustee and chair of the charity Reach Volunteering (<u>reachvolunteering.org.uk</u>).

Colin Copus is an Emeritus Professor of local politics at the Department of Politics and Public Policy, De Montfort University and a Visiting Professor at the University of His academic interests are central-local Ghent. relationships and the constitutional status of local government, devolution, localism, local party politics, local political leadership and the changing role of the councillor. Colin has worked closely with policy-makers and practitioners in central and local government. He was an academic advisor to the Political and the Constitutional Reform Committee and the Communities and Local Government Committee on its inquiry into the role of the



councillor and he is currently the academic advisor to two All Party Parliamentary Groups. He is a member of the Council of Europe's group of experts on the Charter of Local Self Government.

He has published widely in academic journals.

Colin's latest book is entitled: In Defence of Councillors, published by Manchester University Press.

Colin was the editor Local Government Studies 2001 to 2013

He has also served as a councillor on a London Borough council, a county and a district council and three parish councils.

## **Workshop Topics**

Delegates will be able to attend three workshops at the event, chosen from the six options below:

#### A. How to select a candidate for an Honour and write a good nomination

Facilitator: A representative of the Cabinet Office

Have you ever been asked by the Leader or Chief Executive of your council, to identify people in your communities who are worthy of a national honour? That done have they then asked you to complete and submit the nomination form? Have you then waited, in frustration, as the submissions you have put forward are unsuccessful and you are asked to repeat the whole process, either for the same person or for a different nominee, to improve your area's success rate?

This workshop will help you to identify the type of person that is most likely to be honoured and give you tips on completion of the form, to give you a better chance of success.

NACO has invited our contacts in Cabinet Office and DCMS to help us with this session.

#### B. Help Me! - I am now a Civic Officer

Facilitators: Pat Seager, Vice Chair, NACO, Penny Harrison, Secretary and Executive Member NACO and Emara Roth, Executive Member, NACO

If you have suddenly found civics has been added to your portfolio of work or if you are newly appointed to work in the Civic Office then this is the workshop for you. The facilitators have decades of experience of working in the Civic Offices and advising Civic Heads. They are very happy to share their knowledge and help you to feel better prepared in your new role.

They will go through the very many different aspects of life in the civic office and provide a basis for you to create an efficient and well-run office whether you are a one-person band, manage a large civic team or anything in between!

Many people have little idea of what the role of a Civic Office entails and this is your chance to find out. It is often the case that the HR department in an Authority has no idea of what the Civic Officer does other than maintain a diary and organise a few events! There is so much more.

#### C. Working with the Police

Facilitator: Andy Newland, Operational Planner & Counter-terrorism Security Co-ordinator, Avon & Somerset Police

Civic events are diverse in nature and their frequency varies from location to location. They range from Royal Visits, Military Freedom Parades, Civic receptions to Civic Proclamations such as we saw with September's activation of OP LONDON BRIDGE. Delivering events against expectations, collapsing time lines and within accepted best practice or guidance can be a challenge. The most successful events are generally delivered as a collaborative partnership based on relationships formed in 'peacetime'. This workshop is based upon the snapshot experiences gained from within the Avon and Somerset Local Resilience Forum area.

#### D. Support roles within the Civic Office

Facilitators: Adam Tregoning JP & Paul Mayhew, NACO Executive Members and Members of the Guild of Macebearers

The history & traditions of the Mace-Bearer. Dispelling the myths surrounding this ancient role.

Do you have a full time Mace-Bearer (or for example a Sword-Bearer, Town Sergeant or Beadle) or do you find you have to brief part time attendants and are unsure of the protocols?

Do you have to brief Civic Chauffeurs and are unaware of their duties and responsibilities?

This workshop will aim to cover the duties of the support roles within the Civic Office.

## E. Managing Challenging people and difficult situations (Fair Mayor or Night Mayor?)

Facilitator: David McGrath, Link Support Services (UK) Ltd & NACO approved training partner

Brace yourself for a fast paced and lively session – looking at challenging situations faced by Civic Officers working with first citizens – and how to prevent and manage them.

Delivered by former Birmingham Councillor and veteran member and officer trainer (David McGrath of Link Support Services), this session is guaranteed to be thought provoking, make you smile and take action on practical tips to help you survive and thrive in the civic support role.

#### F. Open Mic

Facilitators: Members of NACO Executive

This workshop is specifically designed to pool the ideas and experiences from your colleagues in civic office to help you solve problems you raise.

We will form a panel of NACO members, from a range of backgrounds, to give possible answers to questions, but also stimulate debate from the floor.

Submit your questions in advance or raise them on the day, but come with an open mind and be prepared to contribute, if someone else asks for help with an issue you have successfully addressed.
